

New Government Legislation Programme: Industry & Sector Specific Breakdown Spring/Summer 2018

The Government Legislation Programme of the Partnership Government for the Spring/Summer session has been published. The Cabinet has approved 49 new Bills for priority publication. The programme identifies 33 bills which are expected to undergo pre-legislative scrutiny. 23 Bills are currently before the Oireachtas and 74 other proposed Bills are being considered for introduction in the long-term. 61 Bills have been published since this Government took office in May 2016 and 59 Bills have been enacted since that date.
